Round Two Plus Summer Program  
Summer 2009 Enrollment & Fee Agreement**

The Titusville YMCA's Round Two Plus Summer 2009 Enrichment Program will begin Monday, June 8, 2009 and conclude on Friday, August 28, 2009 from 8:00 am - 5:00 pm Monday - Friday.

Parents and/or legal guardians are responsible for transporting their child(ren) to and from the program each day. Daily components for all participants will include: breakfast, lunch and a mid-afternoon snack, daily swimming, math, reading, and science enrichment; social and cultural activities; technology education; nutrition education; organized physical education activities, and local field trips and out-of-town activity trips. Daily attendance is strongly encouraged so each child can benefit from all activities.

The weekly fee for the Round Two Plus Summer 2009 program is \$60.00 per child. There is a 15% discount for additional children from the same household. There are no pro-rating of program fees, regardless of the number of days your child(ren) attend. All fees are due and payable at the beginning of each week of the program unless prior arrangements have been made – no exceptions.

Please fill out, sign and return the following signed application pages with this signed agreement. They include:

- Financial Assistance Application (if applicable)
- Child Health Assessment Form (required under law with 30 days of enrollment)

The program concludes at 5:00 pm each day. Parent(s) must pick up their child(ren) no later than 5:00 PM. After 5:15 PM a late fee of \$5.00 will be assessed for each 15 minute increment the child has not been picked up. *This applies to full pay, reduced pay, and scholarshiped participants.* If you are going to be late for some unforeseen circumstance, you must call us to make arrangements.
