

Titusville 21st Century Community Learning Center After School Enrichment Program 2009-2010 Program Description & Application Forms

Open enrollment applications are now being taken for the 2009-2010 academic school year for grades 1 – 5 only. Attached are the following forms which MUST be filled out completely to have your application considered. Space is limited- Apply today!!!

- Main Application Form
- Enrollment & Fee Agreement (Must be filled out & signed!)
- Behavior Management Policy Form
- School Information Release Form (required by PA Dept. of Education)
- Health Assessment Form (required through age 12)
- Application for financial assistance (if applicable)

The Titusville 21st Century Community Learning Center will begin September 1, 2009 and run through June 8, 2010 each day that school is in session. The program will begin immediately after school until 6:00 PM.

During the 2009-2010 year the program will be fee-based at \$45.00 per week. There will be a 10% discount for siblings from the same household. There are no pro-rating of fees. There is LIMITED financial assistance available for those families that demonstrate need. A financial assistance application is attached

- The program will be held in its entirety at the Titusville YMCA for students in grades 1-5. Students will be bussed each day by YMCA busses from Main Street, Hydetown, and Pleasantville elementary schools to the YMCA. Transportation will again be offered at the end of the program each day to designated locations as follows: Elm Street apartments on the west end, ECLC on the East end, Hydetown elementary school, and Pleasantville elementary school.
- Weekly components for all students will include: homework assistance; math, reading, and science enrichment; social and cultural activities; technology education; nutrition education; daily supper through the CACFP food program; and organized physical education activities.
- Enrollment forms are available at the Titusville YMCA. Enrollment by grade is limited. Daily attendance is strongly encouraged so each child can benefit from all activities.
